

## SCHOOL RULES

- 1) STUDENT agrees to observe all rules and regulations of the FAA, all state and local air regulations, and use only FAA recognized airports.
- 2) STUDENT is obligated to cancel his/her scheduled flight time under all circumstances including when there is a forecast of less than VFR weather.
- 3) STUDENT agrees to take over or to return an aircraft at agreed time, weather permitting. In the event of delay, STUDENT will phone FFTC immediately upon knowledge of any such delay. After 15 minutes FFTC will automatically charge one full hour - including CFI, if involved - as a cancellation fee.
- 4) STUDENT is responsible for properly tying down and securing the aircraft after each time, including, but not limited to, covering the pitot, placing the control lock, and ensuring that whole electrical system is off, including the master switch.
- 5) STUDENT assumes responsibility for all costs related to damage to the aircraft's electrical system, if the master switch is left "on".
- 6) STUDENT agrees to inspect and make a proper and complete pre-flight check of the aircraft before each take-off as prescribed by the aircraft's manufacturer and FFTC, and will not take-off unless it is in airworthy condition for flight.
- 7) STUDENT agrees that the pilot-in-command assumes all responsibility for operation of the aircraft.
- 8) In the event of an accident, a report to FFTC shall be made immediately. STUDENT shall not, in any manner, aid or abet any claimant, but shall cooperate fully with the insurance company in all matters connected with the investigation and defense of any claim or suit.
- 9) STUDENT is not allowed to fly outside the Continental United States unless prior arrangement is made with FFTC.
- 10) FFTC reserves the right to cancel the rental of the aircraft and take possession of the aircraft at any time and any place when in its judgement there is deemed to be sufficient cause for such actions, and STUDENT agrees to bear all expenses incurred in flying the aircraft back to FFTC's airport base. This includes expenses relating to the transportation of a pilot to the aircraft's location. STUDENT further agrees that if he/she must abandon the aircraft at an airport other than FFTC's home base because of weather or other cause, he/she shall pay the aforementioned expenses incurred in flying the said aircraft back to home base. If the aircraft is abandoned as mentioned above, STUDENT agrees to notify FFTC immediately.
- 11) If STUDENT is negligent in the operation of the aircraft, he/she shall hold harmless and indemnify FFTC.
- 12) STUDENT shall pay all fines, penalties, forfeitures, court costs, and other expenses for parking, landing fees, or other legal violations assessed against FFTC, the aircraft, or STUDENT with respect to the use of the aircraft while on rental to STUDENT.
- 13) Neither FFTC nor its employees shall be liable for loss or damage of any property left, stored, or transported in or upon aircraft whether before or after the return to FFTC.
- 14) All flights shall be made under VFR conditions unless STUDENT is instrument rated and meets all other requirements of the FAA and FFTC. Flight Plans are required to be filed on all cross-country flights. In the case of all flights, FFTC is to be informed prior to departure as to the nature and destination of each flight.
- 15) STUDENT shall not permit anyone else to fly the aircraft.
- 16) STUDENT agrees to hold harmless and indemnify FFTC from any damage FFTC might suffer, including attorney fees, arising out of, or in any way connected with, STUDENT's violation of the terms or conditions of this agreement and/or FFTC's enforcement thereof.
- 17) Use of headphones: During instruction flight, the use of headphones may be required by FFTC. Upon the availability of headphones, they may be rented from FFTC at the published rate. The proper use and care of this equipment is the responsibility of STUDENT to the extent that repair or replacement costs will be the responsibility of STUDENT in the event that such is needed as the result of damage incurred while in the care of STUDENT.
- 18) Regarding aircraft rental: FFTC provides aircraft, applicable documents and associated tow bar. STUDENT is responsible for all other items required for flight. STUDENT is also responsible for the safeguarding of the aforementioned equipment and documents when at facilities other than the base, including adequate tie down and/or sufficient protection from prevailing weather conditions, and in the event that onboard equipment is inoperative, must report such items to FFTC before departure, or as soon as practicable. STUDENT is obligated to return the aircraft and contents in the same conditions as were in effect upon renting the aircraft.
- 19) The aircraft shall not be used for any illegal purposes, including, but not limited to, transporting illegal cargo or passengers. STUDENT agrees to indemnify and hold harmless FFTC from any damage FFTC may suffer as a result of STUDENT's violation of this provision.
